LISTING FEES

Listing Fees are payable with the entry fee for dogs that do not have their Individual CKC Registration Number, or an ERN or a PEN.

To comply with CKC regulations, we will be unable to accept or substitute entries after the closing date or when the allowed number of entries has been reached. **WITH A LIMITED ENTRY WITHDRAWAL OF ENTRY AT ANY TIME IS NOT ALLOWED.**

Entry fees are payable by Cash, Cheque, Money Order. or Bank Draft. If entries are FAXED they must be paid with a VISA Card (we do not accept Mastercard). A 10% Processing Fee will be charged for each VISA transaction.

Each VISA transaction may include one or more dogs.

Any overpayment of less than \$10.00 will not be refunded ~ please consider it as a donation to the trophy fund.

ATTENTION USA EXHIBITORS

Please do not mark cheques "PAYABLE IN CANADIAN FUNDS" or "AT PAR" as such items cannot be cleared through banks and will be returned. Personally discounted cheques are not accepted and will be returned. Thank you.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and enter Canada for the purpose of participating in CKC events will be required to have an ERN. To obtain an ERN please do the following:

1. Send a photocopy of the dog's registration certificate, reflecting current ownership, e.g. an AKC registration certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount of \$50.00 plus 5% GSTax ~ in Canadian Funds ~ to the Canadian Kennel Club, 200 Ronson Dr Suite 400, Etobicoke, Ont M9W 5Z9. Phone (416) 675-5511, Fax (416) 675-6506. Fax requests for ERN are accepted. Please indicate your VISA/Mastercard number, expiry date and name & address of cardholder.
3. Ensure that you provide full return name & address to enable the CKC to forward the ERN to you. The ERN must be applied for within 30 days of the first day a dog entered a CKC Event. Dogs may be entered as "Listed" (and the listing fee paid), however, failure to apply for an ERN within 30 days of the Event will result in cancellation of any wins, awards or scores

PERFORMANCE EVENT NUMBER (PEN) APPLICABLE TO OBEDIENCE/AGILITY TRIALS ONLY

For a dog to be able to receive a PEN the following criteria must be met:

1. The dog must be of a breed recognized by the CKC.
2. The dog for one reason or another, must not be eligible for CKC registration.
3. The dog must be spayed or neutered.
4. The dog cannot be on the CKC Miscellaneous Class
5. A foreign born dog residing in the USA must have been issued an AKC ILP number.

JUDGING SCHEDULES

Judging Schedules will be mailed to all entrants as soon as possible after closing. The schedule will also be posted on the "Canuck" dog show site at www.atlantic.canuckdogs.com ~ instructions to the show site are also to be found at the end of the judging schedule.

BOOTH RENTAL

There will be a silent auction with the bids closing Sunday, after the first Best In Show.

RULES

It is incumbent that each exhibitor in both Conformation and/or Obedience be familiar with the CKC rules which apply to that event. These rule books may be purchased for \$6.00 plus GSTax from the Canadian Kennel Club, 200-Ronson Dr, Suite 400 Etobicoke, Ontario M9W 5Z9

PRIZES & AWARDS

Conformation

Flat ribbons will be awarded in each class for 1st through 4th place, WM, WF, BOW, BOB, BOS & BP. Rosettes will be awarded for Group 1st through Group 4th and Puppy In Group. In addition a monetary award of \$15.00 will be awarded to Group 1st, \$10.00 will be awarded to Puppy In Group. BIS will be awarded a Rosette and \$40.00 and BPIS will be awarded a Rosette and \$25.00.

Obedience

Flat ribbons will be awarded for all dogs attaining a Qualifying Score. Rosettes will be awarded to the dogs attaining a High In Class and the High In Trial Dog. In addition to the rosettes the High In Class dogs will receive a monetary award of \$15.00 and the High In Trial Dog will receive a monetary award of \$40.00

MOVING UP TO SPECIALS ~ CONFORMATION

A dog which is individually registered in the records of the CKC and has completed the requirements for a Championship in accordance with CKC rules, after the closing date and time for the show, may be transferred from one of the Regular Classes to "Specials Only", providing the request is submitted to the Show Secretary in WRITING and on the appropriate form at least one hour prior to the opening of the show, by the owner or handler. When one or more Championship shows are held on the same day, in the same venue the request for moving a class dog to specials must be made prior to the scheduled opening of the show it is being moved up in.

CHAMPIONSHIP POINTS

The schedule to be employed in the determination of the number of points allocated a dog awarded WINNERS shall be as follows:

* Includes the dog awarded WINNERS. The system provides for additional points if the dog awarded WINNERS also placed in the Group. As follows:

A class dog awarded BEST IN SHOW at an All Breed Championship Show will be credited with five (5) points inclusive of any points earned at the Breed or Group level. In no case may a dog earn more than five (5) points at a single show.

In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must (a) earn at least 10 Championship points under at least 3 different judges; and (b) be individually registered in the records of the CKC or have an Event Registration Number (ERN); and, have earned at least one 2 point win either at Breed or Group level.

CONFORMATION CLASSES OFFERED

The following Official CKC Classes divided by sex will be provided

*3 – 6 MONTH PUPPY ~ a dog 3 months and under 6 months on the day of the show

JUNIOR PUPPY ~ a dog 6 months and under 9 months on the day of the show

SENIOR PUPPY ~ a dog 9 months of age but under 12 months on the day of the show

12 - 18 MONTHS ~ a dog 12 months and under 18 months on the day of the show

CANADIAN BRED ~ a dog which was born in Canada

BRED BY EXHIBITOR ~ a dog owned and handled in the ring by the breeder. The handler must be the owner/co-owner and breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class but need not handle the dog for further awards.

OPEN CLASS ~ all dogs

SPECIALS ONLY ~ dogs which have recorded CKC Registration or have an ERN number and have attained the required points for Championship status.

*Dogs 3 months of age and under 6 months of age on the day of the show may be entered in Exhibition Only, providing that the owner of the puppies has also entered a dog in one of the regular classes. Puppies in this category may NOT compete in any official, unofficial or non-regular classes including parades nor are they required to be listed in the catalogue. The Club has restricted the number of entries in this class to 30 per show

OBEDIENCE TRIAL MOVE UP

A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules may be moved up to the next level of Obedience Competition providing the transfer was submitted to the Trial Secretary, in WRITING, by the owner or handler, one hour prior to the opening of the first trial, When one or more trials are held on the same day at the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up to. TRIAL SCHEDULING PERMITTING.

OBEDIENCE CLASSES OFFERED

(T) Transition Classes

(T) Pre Novice ~ for dogs not ready for Novice Competition

(T) Novice Intermediate Class ~ for dogs that have earned the title CD and any other advanced obedience title in Canada

(T) Novice "C" ~ open to any dog of either sex that had gained the title CD, CDX, UD or any other advanced obedience title in Canada prior to the closing date of the trial.

(R) Regular Classes

(R) Novice "A" Class ~ for dogs handled by owners, co-owners or immediate family members through all exercises
(R) Novice "B" Class ~ for trainers, multiple entries, exhibitors who have attained a Cdn OTCh degree or dogs that have earned a title in another country

(R) Open "A" ~ for dogs who have earned a Canadian CD and must be handled through all exercises by the owner, co-owner or immediate family member. Not for persons with multiple entries

(R) Open "B" ~ for dogs who have earned a Canadian CD and may be handled by the owner or by any other person through all exercises.

(R) Utility ~ for dogs that have earned a Canadian CDX.

Transition Classes (T) ~ Pre Novice, Novice "C" and Novice Intermediate do not compete for High In Trial

PLEASE NOTE ~ BITCH IN SEASON ~ RETURN OF ENTRY FEES

A full refund of entry for a bitch in season entered in one or more of the Obedience Trials will be made if the withdrawal of entry for such a dog is accompanied by a Veterinarian's Certificate certifying that the bitch was in season within 10 days preceding the Trials, is delivered to or reaches the Trial Secretary on or before the date of the trials.

GENERAL INFORMATION

1. The building will be open at 6 p.m. on Friday September 27th 2008, to allow exhibitors and vendors to set up.
2. Incomplete entries will be returned. AGENTS and/or OWNERS filling out the Entry Form please ensure that the name and address of the owner(s) are clear and correct and that the Agent's (if there is an agent) name and address also be clearly filled out.
3. To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Show/Trial Secretary after the closing date.
4. Only dogs eligible for CKC Registration may enter this show, and its precincts. The Committee reserves the right to refuse any entry subject to CKC rules.
5. No entry will be accepted unless accompanied by proper entry fees and correct forms.
6. The Show & Trial Superintendent will be in complete charge of these events.
7. Judging will not be delayed to accommodate an exhibitor or handler who fails to have his/her dog(s) at ringside when called.
8. Any dog excused by the Judge, Superintendent, or Veterinarian for any reason shall not, after being excused, compete in any class or for any awards for the remainder of the show/trial.
9. "Puppy" or "Dog" For Sale signs will not be permitted in the building.
10. The Miramichi Kennel Club will use all care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, nor assume liability, in the event of an accident or any misfortune to either dog, exhibitor or patron.
11. If because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund or return of entry fees will be made.
